If aggravated circumstances prevail, the fixed established imprisonment may be increased to a maximum of five (5) years; if attenuating circumstances prevail, it may be reduced to a minimum of two (2) years.

I **understand** that New York Life Insurance Company has the right to require additional information and, if necessary, an examination by a physician. I ask New York Life to rely on all such statements made on this form, and any supplements to it, while considering this request. I also understand that the coverage afforded will be in consideration of the answers and statements set forth above.

AUTHORIZATION: I hereby authorize any licensed physician, medical practitioner, hospital, pharmacy, clinic or other medical or medically related facility, laboratory, insurance company or MIB, LLC ("MIB"), or other organization, institution or person, that has any records or knowledge of me or my health to release information, including prescription drug records, maintained by physicians, pharmacy benefit managers, and other sources of information to New York Life Insurance Company, its reinsurers, its subsidiaries or the plan administrator about the physical and mental health of any persons proposed for insurance, including significant history, findings, diagnosis and treatment, but excluding psychotherapy notes for the purpose of evaluating my application for insurance. Health information obtained will not be re-disclosed without my authorization unless permitted by law, in which case it may not be protected under federal privacy rules. IMPORTANT NOTICE:

How New York Life Obtains Information and Underwrites Your Request For The Group Disability Income Insurance

In this notice, references to “you” and “your” include any person proposed for insurance. Information regarding insurability will be treated as confidential. In considering whether the person(s) in your request for insurance qualify for insurance, we will rely on the medical information you provide, and on the information you AUTHORIZE us to obtain from your physician, other medical practitioners and facilities, other insurance companies to which you have applied for insurance and MIB, LLC (“MIB”). MIB is a not-for-profit organization of insurance companies, which operates an information exchange on behalf of its members. If you apply for life or health insurance coverage or a claim for benefits is submitted to an MIB member company, medical or non-medical information may be given to MIB and such information may then be furnished by MIB, upon request, to a member company.

Your AUTHORIZATION may be used for a period of 24 months from the date you signed the application for insurance, unless sooner revoked. The AUTHORIZATION may be revoked at any time by notifying New York Life in writing at the address provided. Your revocation will not be effective to the extent New York Life or any other person already has disclosed or collected information or taken other action in reliance on it, or to the extent that New York Life has a legal right to contest a claim under an insurance certificate or the certificate itself. The information New York Life obtains through your AUTHORIZATION may become subject to further disclosure. For example, New York Life may be required to provide it to insurance, regulatory or other government agencies. In this case, the information may no longer be protected by the rules governing your AUTHORIZATION.

MIB and other insurance companies may also furnish New York Life, its subsidiaries or the Plan Administrator with non-medical information (such as driving records, past convictions, hazardous sport or aviation activity, use of alcohol or drugs, and other application for insurance). The information provided may include information that may predate the time frame stated on the medical questions section, if any, on this application. This information may be used during the underwriting and claims processes, where permitted by law.

New York Life may release this information to the Plan Administrator, other insurance companies to which you may apply for life and health insurance, or to which a claim for benefits may be submitted and to others whom you authorize in writing. However, this will not be done in connection with test results concerning Acquired Immune Deficiency Syndrome (AIDS) or Human Immunodeficiency Virus (HIV). We may also make a brief report of your protected health information to MIB, but we will not disclose our underwriting decision.

New York Life will not disclose such information to anyone except those you authorize or where required or permitted by law. Information in our files may be seen by New York Life and Plan Administrator employees, but only on a “need to know” basis in considering your request. Upon receipt of all requested information, we will make a determination as to whether your request for insurance can be approved.

If we cannot provide the coverage you requested, we will tell you why. If you feel our information is inaccurate, you will be given a chance to correct or complete the information in our files. Upon written request to New York Life or MIB, you will be provided with non-medical information. Generally, medical information will be given either directly to the proposed insured or to a medical professional designated by the proposed insured. Your request is handled in accordance with the Federal Fair Credit Reporting Act procedures. If you question the accuracy of the information provided by MIB, you may contact MIB and seek a correction. DISABILITY INSURANCE

WHAT IT IS AND WHY YOU MAY NEED IT

Your ability to earn an income is a significant asset. Even if you are young and healthy, a serious illness or injury could put you out of work for months or even years—thus jeopardizing your livelihood. Adequate disability insurance coverage helps protect your family from financial catastrophe that could result from the loss of your income. This Group Disability Income Insurance Plan, sponsored by IMA, can be a reliable source of disability income protection. You probably insure your home, car, even your life. Help protect your income too.

WHO IS ELIGIBLE?

IMA Members who are under age 60 and at FULL-TIME WORK can request coverage, provided they reside in the United States except (AK, DE, FL, LA, MD, ME, MO, MT, NH, NV, NM, NC, OH, SD, TX, UT, VT, WA and WY) and Puerto Rico and have an ANNUAL NET EARNED INCOME of at least \$20,000. However, members on active duty in the armed forces are not eligible. "FULL-TIME WORK" means the active performance of the regular duties of your normal occupation on the basis of at least 30 hours per week at the place where such duties are normally performed.

"Gross ANNUAL EARNED INCOME" means your wages, salaries, commissions, fees and other amounts received for personal services — before deduction of income or social insurance taxes and after deduction of normal business expenses which are deductible for income tax purposes — for any 12-month period.

It does not include income from interest, dividends, rent, royalties, annuities, other insurance or other unearned income.

HOW TO DETERMINE YOUR NEEDS

Before you can determine what you may need, you should understand what disability coverage you might already have. Below is a brief description of the traditional mainstays for this coverage. Consider carefully how each one may benefit you.

Employer-provided disability benefits are available to many IMA members. But even if your employer offers disability insurance, don't assume you're adequately protected.

The amount of coverage provided and the length of time benefits are paid vary widely with each policy. Find out from your employer what kind of benefits you could expect. Specifically, you should ask:

- A. How long after I become disabled must I wait before benefits begin?
(This is known as a "Waiting Period.")
- B. How long are benefits paid during disability?
- C. What percentage of my salary will these payments represent?

Social Security You should contact your local Social Security office to determine what benefits would be available to you. Don't assume this program will provide adequate insurance protection in the event of any disability—it may not.

Worker's Compensation benefits may be paid by your state in instances where an accident or illness has occurred at your place of work, or as a result of your employment. As an accountant, your chances of having a job-related injury and subsequently receiving Worker's Compensation benefits are probably low. Like employer-provided plans, state benefits vary widely.

Individually purchased disability coverage offer a variety of options and benefits. These help bridge the gap between disability benefits you may be eligible to receive and the income level you will need without your regular paycheck. Most disability income insurance cover only a percentage of your full salary, usually 50 to 70%. (You may not need to replace your entire salary as you may save significantly on taxes, transportation, clothing and other work-related expenses.)

Two Plans for Flexibility

CAREER PLAN

The Career Plan option will pay benefits up to age 65 for covered disabilities due to accident or illness that begin prior to age 64, or for one year for disabilities beginning at age 64 or older.

FIVE-YEAR PLAN

The Five-Year Plan option will pay benefits up to five years for covered disabilities due to accident or illness that begin prior to age 60, up to age 65 for disabilities beginning on or after age 60 but before age 64, or for one year for disabilities that begin at age 64 or older or for one year for disabilities that begin at age 64 or older.

Monthly benefits will be paid up to the maximum benefit period selected. Monthly benefits under either plan will end on the date you fail to give required proof of continuing disability, your disability ends, the maximum benefit period ends or you die. Under either Plan, benefits are limited for disabilities due to mental disorders and chemical dependency. See EXCLUSIONS AND LIMITATIONS.

Select Your Monthly Benefit

You may apply for benefits ranging from \$400 to \$5,000 a month, in \$100 units. The Monthly Benefit you request, combined with any other disability coverage you have or for which you are applying, may not exceed 70% of your Average Monthly Income.

Average Monthly Income

Average Monthly Income pay means your monthly rate of pay from your employer. Such rate will be that in effect on the day before total disability begins. Average Monthly Income includes commissions but not bonuses, overtime pay or other extra compensation. For members who are self-employed, Average Monthly Income means the average Net Monthly Income from the personal practice of your profession.

Average Monthly Income excludes investment returns, rents, royalties and similar income not directly produced by your occupation. Average Monthly Income is computed before deduction of any income taxes or social insurance taxes; and after deduction of normal and usual business expenses that are deductible for income tax purposes. It is computed for the period that produces the highest figure: the immediately preceding tax year; the immediately preceding two tax years; or the entire period, if less than 12 months before deduction of any income taxes or social insurance taxes; and after deduction of normal and usual business expenses that are deductible for income tax purposes.

Choose the Waiting Period

The Waiting Period establishes when your monthly benefits can begin. You can request that benefits begin on the 31st, 61st, or 181st day of your disability. The longer you choose to wait, the more economical your premium will be.

IMPORTANT INFORMATION

Helps Protect You as an Accountant

You will be considered totally disabled, during the waiting period and beyond if you are prevented by illness or injury performing the material and substantial duties of your regular occupation.

You must be under the regular care of a physician (other than yourself) and must not be engaged in the full-time practice of law.

Premiums Waived If You Are Totally Disabled

If you begin receiving benefits for covered total disability while the program is in force, premiums due thereafter will be waived during the remainder of the disability. When you stop receiving monthly benefits, premiums must again be paid when due.

Renewability and Termination

The insurance company cannot terminate coverage or change premiums on an individual basis. It may only do so on a class-wide basis. While the Group Policy remains in force, you can renew your Disability Income Insurance until age 70, provided you continue active FULL-TIME WORK, remain an IMA member and pay premiums on time.

TERMS OF COVERAGE

YOUR EFFECTIVE DATE

Insurance for the Group Disability Income Insurance Plan becomes effective on the first of the month after the date the application is approved by the New York Life Insurance Company, provided the first premium has been paid. You must be actively at FULL-TIME WORK on the date insurance is to take effect. If not, insurance will take effect on the day you resume such work. Payment of a premium contribution for insurance does not mean there is any coverage in force before the effective date specified by New York Life Insurance Company. Note: There are instances where New York Life Insurance Company may be able to offer insurance, at the same cost, by eliminating coverage for a specified impairment or disease.

WHEN COVERAGE ENDS

Your insurance will end at the earliest of the date the group policy ends; the date the policy is amended to end insurance for your class; the end of the period for which the last premium has been paid by you; the date you cease FULL-TIME WORK for reasons other than total disability; the premium due date coinciding with or next following the date you cease to be an IMA member; you commence full-time active military duty, or; the premium due date coinciding with or next following the date you attain age 70.

EXCLUSIONS AND LIMITATIONS

No benefits are payable for any disability that is due or related to: intentionally self-inflicted injury whether sane or insane; war or act of war; normal pregnancy or childbirth or voluntary abortion (complications of pregnancy are covered); committing a crime or an attempt to do so (except as a victim) an illegal occupation/activity or the commission of a crime; or military service. No benefits are payable for any disability for which you are not under the regular care of a licensed physician or surgeon other than yourself or member of your immediate family or household; or for any condition that is specially excluded from your coverage.
